Exterior paints and wood stains (dry-film protection): Use 0.4-1.2% of Polyphase PW40. For hot, humid areas use up to 2.0%.

Interior paints and wood stains (dry-film protection): Use 0.1-0.4% of Polyphase PW40.

Cutting oils: Use 0.05-0.5% of Polyphase PW40. **Paper Coatings:** Use 0.05-0.2% of Polyphase PW40. **Adhesives:** Use 0.05-0.2% of Polyphase PW40.
