NATURE OF RESTRICTION: For use by authorized customers where the vendor maintains a record of sales, including the name and address of the purchaser, amount purchased together with a signed Notice to Purchaser. Frontiersman® Xtra Bear and Mountain Lion Attack Deterrent is designed to be used in wilderness applications to help defend individuals needing assistance when confronted by aggressive bears and mountain lions. This product is for spraying the face of aggressive bears and mountain lions only and is not to be used against domestic animals or human beings.

This product has an effective range up to 12.2 metres (40 feet).

NOTE: One of the following optional statements will be used, depending on which size of canister is being used:

[The 225 g canister empties in approximately 6-7.0 seconds]

[The 260 g canister empties in approximately 6-7.0 seconds]

[The 325 g canister empties in approximately 6-7.0 seconds]

[The 460 g canister empties in approximately 9.0 seconds]

APPLICATION DIRECTIONS: FOR OUTDOOR USE ONLY. Capsaicin sprays have been proven effective in repelling aggressive bears and mountain lions only when sprayed directly into the face, especially in the eyes or on the nose of the animal. This product is only to be used to deter aggressive bears or mountain lions that are attacking or about to attack people. **DO NOT** seek out encounters with bears or mountain lions. There is no guaranteed method of responding to an aggressive bear or mountain lion encounter because each encounter is unique. This product is a bear and mountain lion attack repellent that may protect users in some unexpected confrontations with these animals but may not be effective in all situations or prevent all injuries. Strict attention to the advice of wildlife professionals on safety is advised. This product must be used only as a last resort. Capsaicin sprays will not repel bears or mountain lions from treated objects or areas. **DO NOT** spray objects (e.g., tents, clothing) or areas with this product. **DO NOT** use this product against people or non-target animals. **READ THIS ENTIRE LABEL BEFORE TAKING THIS PRODUCT INTO AREAS WHERE AGGRESSIVE BEARS OR MOUNTAIN LIONS MIGHT BE ENCOUNTERED.**

DO NOT apply to any body of water. Special procedures must be followed to arm the container, apply the product and restore the safety clip to disarm the container. Before taking this product into bear or mountain lion country, read the directions below and familiarise yourself with these procedures. If you test-fire this container, make sure to discharge downwind and do not depress the actuator tab for more than one-half a second. Do not test-fire in areas inhabited by bears or mountain lions . After test firing, clean nozzle and can with soap and water to remove all residues from the can.

TO ARM AND APPLY: This product is designed for one-hand operation. Place forefinger through hole in handle, with thumb on safety clip curl. Pull safety clip straight back and off using thumb (Figure 1). Depress actuator tab for burst of spray (Figure 2).

Aim at the face and eyes of bear or mountain lion. Press trigger for 3 seconds in order to create a barrier of spray between you and the bear or mountain lion. Stop to evaluate the impact of wind and other factors and adjust your aim if needed before spraying again. The maximum effective range is 12.2 metres (40 feet). Spray is most effective at short range. Avoid discharging upwind and, after discharging, move away to avoid exposure to spray.

TO DISARM: Replace safety clip by firmly pushing with thumb until audible "snap" is heard (Figure 3).

Check to see if safety clip is securely in place. No gap should be visible between the actuator handle and the safety clip.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Severe irritation to eyes, nose, respiratory and skin areas can occur. Persons with respiratory problems or wearing contact lenses should not use this product. Avoid contact with skin and eyes and avoid inhalation of spray. Wash hands before touching eyes or face and prior to using the washroom. **WHEN TRAVELLING DO NOT STORE IN PASSENGER COMPARTMENT.** Contact air carriers for regulations concerning air transport. Contents under pressure. Container may explode if heated. Do not place in hot water or near radiators, stoves or other sources of heat. Do not use in the presence of open flame or spark or while smoking. Do not leave in hot vehicle. For safety and performance, do not store above 50°C or below 0°C. Be careful not to puncture the container. **DO NOT INCINERATE THE CONTAINER.** Use of this product is for spraying the face of aggressive bears or mountain lions only and is not to be used against domestic animals or human beings. Capsaicin sprays will not repel bears or mountain lions from treated objects or areas. Do not spray objects (e.g., tents, clothing) or areas with this product.

FIRST AID:

If in eyes: hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DISPOSAL: When the container is empty, press valve to release all remaining pressure. Dispose of empty container in accordance with Provincial/Territorial requirements.
