DIRECTIONS FOR USE

To be used only for the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin of clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. KEEP OUT OF REACH OF CHILDREN.

Harmful if swallowed. Wash thoroughly with soap and water after handling. Severely irritating to the eye. DO NOT get in eyes.

Prevent forming of dust clouds. Finely dispersed particles can be ignited causing a dust explosion.

STORAGE:

Store in original container in a cool, dry, dark place.

DISPOSAL:
