DIRECTIONS FOR USE:

To protect <u>horses</u> from attacks of Horse Flies, Face Flies, House Flies, Horn Flies, Black Flies, Mosquitoes and Gnats: Spray about 3 seconds on each side being careful to spray back, withers and forelegs thoroughly. Do not spray on face. To protect from face flies, spray onto a cloth and wipe on face avoiding eyes, nose and mouth. Repeat treatment when flies are troublesome.
