For outdoor use on ant hills around buildings to kill ants.

For outdoor use to kill wasps, hornets and yellow jackets in their nests.

DIRECTIONS FOR USE

SHAKE CAN WELL BEFORE USING. Test a small inconspicuous area for color fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and lightly spray. Cover fishbowls when spraying. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation. For spot and crack & crevice treatments, affix the white actuator to the spray canister to apply the product as a coarse spray. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices to kill listed insect pests. For the outdoor use to kill wasps, hornets and yellowjackets in their nests, affix the red actuator to the spray canister to apply the product as a jet stream. Reaches nests more than 17 feet above ground.

FOR INDOOR USE IN BUILDINGS AND FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS AND ON PORCHES, PATIOS AND DECKS

HOW TO APPLY

DO NOT APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT. Apply as an indoor crack and crevice or indoor or outdoor spot treatment only.

CRACK AND CREVICE is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

SPOT APPLICATION is localized to a surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room (indoors) or total surface area treated (outdoors).

USE LIMITATIONS FOR ALL USES

DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Any food/feed accidentally contaminated with spray solution must be discarded.

DO NOT apply when people, pets or livestock are present.

DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.

DO NOT allow spray to drip or allow drift onto non-target surfaces.

DO NOT apply to people, pets, livestock or sources of electricity.

DO NOT apply to mattresses, linens, toys, or clothing.

When applied indoors, ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.

When applied outdoors: DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs). Avoid spraying vegetation and non-target structural surfaces. Hose off

any plants or non-target structural surfaces that are contacted with spray with water. When applied to the exterior surfaces of buildings, garbage cans and on patios, porches and decks, DO NOT treat soil, turf or other plants adjacent to the treatment site.

DO NOT apply to overhead areas or in confined spaces (for example, indoors in attics, crawlspaces, small storage rooms, closets; and outdoors to eaves, soffits (except when using to control wasps/hornets/yellow jackets in their nests)).

INDOOR USE

To kill spiders, sow bugs, earwigs, cockroaches, crickets, silverfish, ants and carpet beetles. Thoroughly treat indoor building surfaces in hard-to-reach areas including cracks and crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; garbage cans; localized areas of floors and floor coverings; and points of entry (e.g., around windows and doors). DO NOT exceed 5 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To kill fleas and brown dog ticks: DO NOT apply to pet bedding, furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors; along and behind baseboards, window and door frames; and localized areas of floor and floor coverings. DO NOT exceed 5 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area.

OUTDOOR USE

To kill spiders, sow bugs, earwigs, cockroaches, crickets, ants, fleas, brown dog ticks, house flies, and cluster flies: For use as a spot treatment only on the exterior surfaces of buildings, garbage cans and on patios, porches and decks. Apply to the outside surfaces of foundations, under eaves, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. House flies and cluster flies will be killed when they land and crawl on the treated surfaces. DO NOT exceed 5 seconds per m². Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

FOR OUTDOOR USE ON ANT HILLS

To kill ants: Directly spray ant hills and trails. DO NOT exceed 5 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

FOR OUTDOOR USE TO KILL WASPS, HORNETS AND YELLOWJACKETS IN THEIR NESTS

To kill wasps, hornets and yellowjackets in their nests: For outdoor use only. The best time to spray/apply the product to nests is in late evening or early morning, during cooler

temperatures, and when most insects are at rest inside the nest. Observe for little activity around the nest opening. Spray/apply only if the air is still. Stand at a safe distance of 2 to 2.5 m from the nest. **DO NOT** stand directly under the nest. Treated insects may fall out of the nest and die. Hold container upright at arm's length. Point the spray nozzle in direction of the nest. First, spray into the opening of the nest. Then spray the rest of the nest until it is saturated. Allow sufficient time for insects to die. Any insects returning to the nest after treatment will be killed. Wait at least 48 hours or until no signs of activity before removing the nest. **DO NOT** exceed 9 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through skin. Avoid contact with skin, eyes and clothing. Avoid breathing spray mist. Wash thoroughly with soap and warm water after using. Contents under pressure. **DO NOT** place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C as container may burst. **DO NOT** puncture or incinerate container or spray near open flame or spark, or while smoking. **DO NOT** spray asphalt shingles, as this product may stain them. **DO NOT** apply this product around equipment due to possibility of shock hazard.

ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to evening when most bees are not foraging. For the treatment of stinging insect nests, this product is intended for use on yellow jackets, hornets and wasps only. Toxic to beneficial arthropods (which may include predatory and parasitic insects, spiders, and mites). Minimize exposure to non-target areas.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and PCP Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Skin exposure may cause transient sensations (tingling, burning, itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or

shortness of breath), nausea, headache or dizziness. Contains petroleum distillate. Vomiting may cause aspiration pneumonia. Treat symptomatically.

DISPOSAL

DO NOT reuse empty containers. When container is empty, press valve to release all remaining pressure. Wrap container in several layers of newspaper and discard in garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.

STORAGE

Store in a cool dry area away from heat. Store this product away from food or feed.
