## **NOTICE TO USER**

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

## **FIRST AID:**

If swallowed, call a poison control centre or doctor immediately for treatment advice. **DO NOT induce** vomiting unless told to do so by a poison control centre or doctor. **DO NOT** give **any** liquid to the person. **DO NOT** give anything by mouth to an unconscious person. If in eyes, hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15 - 20 minutes. ## **TOXICOLOGICAL INFORMATION:**

This product contains petroleum distillate. Skin exposure may cause transient sensations (tingling, burning itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness. Vomiting may cause aspiration pneumonia. Treat symptomatically.

## **PRECAUTIONS:**

**KEEP OUT OF REACH OF CHILDREN.** May be harmful if swallowed, inhaled or absorbed through skin. Avoid contact with skin, eyes and clothing. Avoid breathing spray mist. Wash thoroughly with soap and warm water after using. Cover fish bowls when spraying. **DO NOT** contaminate animal feeding areas. Contents under pressure. **DO NOT** place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C as container may burst. **DO NOT** puncture or incinerate container or spray near open flame or spark, or while smoking.

## **ENVIRONMENTAL PRECAUTIONS:**

Toxic to aquatic organisms. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to evening when most bees are not foraging. Toxic to beneficial arthropods (which may include predatory and parasitic insects, spiders, and mites). Minimize exposure to non-target areas.

## **DIRECTION FOR USE:**

For use as a spot or crack and crevice treatment to control insects listed on front panel. Kills on contact and provides residual killing action. Within the specified use location, to enhance effectiveness of this product, apply directly to the listed pests where possible. When applied indoors, good sanitary practices should be maintained to prevent re-infestation.

## **GENERAL DIRECTIONS:**

Hold container approximately 30 cm from surface being sprayed and spray until wet.

Thorough applications produce a coating which will vapourize into cracks and crevices for insect control.

The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated for colour fastness and staining. Evaluate 30 minutes after test application for potential staining. Regardless of the test results, **DO NOT** apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day. (**DO NOT** apply to tapestries, wall paper or similar materials that may be stained).

### **Use Limitations**

- **DO NOT** apply to overhead areas or in confined spaces (for example, indoors in attics, crawlspaces, small storage rooms, closets and outdoors to eaves, soffits).
- When applied indoors, ventilate treated areas after application by opening windows and doors, or using fans where required to aid in the circulation of air.
- **DO NOT** apply when people or pets or livestock are present.
- **DO NOT** allow people or pets or livestock to enter treated areas until sprays have dried.
- **DO NOT** allow spray to drip or allow drift onto non-target surfaces.
- **DO NOT** apply to people, pets, livestock or sources of electricity.
- **DO NOT** apply to mattresses, linens, toys or clothing.
- When applied outdoors: **DO NOT** apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs).
- When applied outdoors to the exterior surfaces of buildings and on listed structures: **DO NOT** treat soil, turf or other plants adjacent to the treatment site.
- **DO NOT** apply to any body of water.
- **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.
- **DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash them following treatment. Any food/feed accidentally contaminated with spray solution must be discarded.

### **FOR INDOOR USE AT BUILDINGS AND FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS AND ON PORCHES, PATIOS AND DECKS**

#### **How to Apply:**

**DO NOT APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT.**

Apply as an indoor crack and crevice or indoor or outdoor spot treatment only. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. Spot application is localized to

a surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room (indoors) or total surface area treated (outdoors).

### **Indoor Use:**

#### **To Kill Ants, Carpet beetles, Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders, Silverfish.**

Thoroughly treat indoor building surfaces in hard to reach areas, including cracks and crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g. refrigerators and stoves) and furniture (e.g., drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; garbage cans; localized areas of floor coverings; and points of entry (e.g.; around windows and doors). **DO NOT** exceed 9 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

#### **To Control Brown dog ticks and Fleas:**

**DO NOT** apply to pet bedding, furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors; along and behind baseboards, window and door frames; and localized areas of floor and floor coverings. **DO NOT** exceed 9 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area.

### **OUTDOOR USE:**

#### **To Kill Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Ants, Fleas, Brown Dog Ticks, House Flies and Cluster Flies**

For use as a spot treatment only on the exterior surfaces of buildings, garbage cans and on porches, patios and decks. Apply to the outside surfaces of foundations, around light fixtures and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of porches, patios and decks. House flies and cluster flies will be killed when they land and crawl on the treated surfaces. **DO NOT** exceed 9 seconds per m<sup>2</sup>. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

### **STORAGE:**

Store this product away from food or feed.

### **DISPOSAL:**

- When container is empty, press button to release all pressure.
- **DO NOT** puncture or incinerate.
- **DO NOT** reuse the empty containers.

Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
