DIRECTIONS FOR USE

Remove protective cap and insert the extension tube into the spray nozzle.

Bed Bugs:

Before application, shake container for a few seconds, then spray a thin even layer of DE Labs Perfect Room Plus onto surface to be treated. Apply as a crack and crevice, spot or void treatment. Take beds apart, spray all frames and joints. Spray mattress, particularly around seams tufts, folds and edges. Treat box springs, bed frame and other furniture where these insects may be found. Cover with clean bedding before using. Bed bugs may also be found in areas of the room away from the bed or furniture. Spray directly into cracks and crevices where these pests are found or may hide along and behind baseboards, moldings and floors underneath objects (e.g./ floors underneath bed and nightstand). Apply to wall voids, behind wall hangings, floor molding, window casings, carpet edge, and other cracks and crevices or voids. Apply directly to the bed bug if possible. Repeat as required.

INDOOR USE: Lightly coat the areas where these pests are found or may hide such as cracks and crevices, behind and beneath stoves, refrigerators, sinks, cabinets, baseboards, garbage cans, around pipes and drains, window frames and in attics and basements. Hit insects directly where possible. Repeat treatment as necessary.

OUTDOOR USE: Lightly coat the areas where these pests are found or may hide including patios, windows, door frames and sills, outside of entrance ways, around foundations, and along ant trails. Repeat treatment as necessary.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not use in presence of open flame or spark or while smoking. **CONTENTS UNDER PRESSURE.** Container may explode if heated. Do not expose to temperature above 50°C /122°F.

Avoid breathing dust and vapours. Avoid contact with eyes, skin or clothing. Use adequate ventilation when handling, during application, and clean-up activities. When used indoors in residential settings, do not apply in the immediate vicinity of people or pets. Wash hands after use.

DISPOSAL:

FIRST AID

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
