AQUA COASTAL BROMINATING PUCKS, when used as directed, are effective as a swimming pool water sanitizer.

WARNING: Direct Puck contact may cause bleaching of vinyl, synthetic or painted pool surfaces. Automatic feeding devices employing these Pucks must be totally free from traces of other pool sanitizers to avoid the probability of an explosion.

PRECAUTIONS:

KEEP OUT OF THE REACH OF CHILDREN. Dangerous gas formed when mixed with acid. Do not mix with any other chemical. Strong oxidizing agent. May cause fire or explosion if contaminated. Corrosive to eyes and skin. Causes eye damage and skin burns. Potential skin sensitizer. Skin exposure to dust may cause allergic skin reaction in some individuals. Dust may be harmful or fatal if inhaled. Do not breathe dust. Harmful or fatal if swallowed. Do not swallow Do not get in eyes, skin or clothing. Wear rubber gloves and goggles when handling.. Keep container closed and store in a cool, dry location.

DISPOSAL:

Rinse container thoroughly before discarding. Do not reuse empty container. Offer for recycling if available, or dispose in accordance with local and provincial regulations.

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Treat symptomatically.

DIRECTIONS FOR USE:

NOTE: Check expiry date of the test kit as test results may be inaccurate if used after that date. In newly filled pools, shock the pool if necessary with a non-chlorine shock.

1. Maintain recommended daily levels as determined by testing kits.

Total Bromine Residue: 1.0- 3.0 ppm

pH:7.2-7.8

Total Alkalinity: 100-150 ppm

Calcium Hardness: 200 - 300 ppm

2.If using in automatic feeding device, fill the chamber(s) with Pucks and adjust flow rate, according to manufacturer's recommendations, to maintain proper bromine residual. Adding AQUA COASTAL Brominating Pucks to the pool's skimmer basket is an alternative method. Daily usage should approximate 25 g of AQUA COASTAL Brominating Pucks per 10,000 L of pool water to maintain a bromine residual of 1.0- 3.0 ppm.

NOTE: Hot weather, heavy pool usage, and rain may require higher usage rates to maintain proper bromine residuals.

3. Periodic super-chlorination of pool water is recommended. Follow label instructions of super-chlorination product being employed.

This product is toxic to fish. Do not discharge into lakes, streams, ponds, or public waters. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
