#### GENERAL INFORMATION

PACER is a surfactant for use with RoundUp®, Muster®, Ultim®, Pinnacle®, Elim® and Ally® in situations where a non-ionic surfactant is called for (minimum or zero tillage systems surfactant additive etc.). Follow label directions for each respective herbicide when using in combination with PACER.

#### PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Do not store or place near open flames or sources of heat. Do not apply more surfactant than is recommended or excessive run-off may occur. Avoid contact with eyes. Remove contaminated clothing and launder before reuse.

#### FIRST AID

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor centre or doctor for treatment advice.

#### DISPOSAL

- (1) Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- (2) Make the empty, rinsed container unsuitable for further use.

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

#### DIRECTIONS FOR USE

#### With Roundup®:

Add 350 mL of PACER per hectare to the spray solution. The spray volume should not be greater than 100 litres of clear water per hectare.

#### With Muster® and Muster Toss N Go:

For maximum weed killing effect, after the addition of Muster to water in the tank, add 200 mL of PACER for each 100 litres of spray solution (0.2% total spray volume). An anti-foaming agent may be needed to reduce foaming.

#### With Ally®:

For maximum weed killing effect, after the addition of Ally to water in the tank, add 200 mL of PACER for each 100 litres of spray solution (0.2% total spray volume). An anti-foaming agent may be needed to reduce foaming.

#### With Ultim<sup>TM</sup>:

For maximum weed killing effect, after the addition of Ultim to water in the tank, add 200 mL of PACER for each 100 litres of spray solution (0.2% total spray volume). An anti-foaming agent may be needed to reduce foaming.

#### With Pinnacle®:

For maximum weed killing effect, after the addition of Pinnacle to water in the tank, add 100 mL of PACER for each 100 litres of spray solution (0.1% total spray volume). An anti-foaming agent may be needed to reduce foaming.

#### With Elim<sup>TM</sup> EP:

For maximum weed killing effect, after the addition of Elim EP to water in the tank, add 200 mL of PACER for each 100 litres of spray solution (0.2% total spray volume). An anti-foaming agent may be needed to reduce foaming.
