May be used on tubs, showers, shower doors, basins, glazed ceramic tile, tile, sinks, counters, stainless steel, fixtures, fibreglass, vinyl and glazed porcelain surfaces. (Spot test for all other hard, non-porous surfaces). On chrome, rinse with water. Not recommended for use on acrylic, brass or natural marble. When used on food contact surfaces such as countertops, rinse the treated surface with potable water after applying the product.

DIRECTIONS FOR USE:

SHAKE WELL BEFORE AND DURING USE.

#### TO CLEAN

Spray 15-20 cm from surface to be cleaned. Allow foam to penetrate dirt and soap scum. For heavily soiled areas, let stand more than 1 minute before wiping. Remove by rinsing with water or wiping with a wet cloth or sponge. On chrome, rinse with water.

#### TO KILL 99.9% OF BACTERIA

Spray 15-20 cm from surface to be sanitized until thoroughly wet. Let stand 1 minute. Remove by rinsing with water or wiping with a wet cloth or sponge. For heavily soiled areas a pre-cleaning is required.

#### TO INHIBIT & PREVENT THE GROWTH OF MOLD AND MILDEW

Remove gross filth or heavy soil prior to applying the product for treatment against mold and mildew. Spray 15-20 cm from surface until thoroughly wet. Let stand for 1 minute. Then wipe. Reapply as needed.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not use or store near heat or open flame. Exposure to temperature above 54° C (130° F) may cause bursting. Do not puncture or incinerate container. Causes slight eye irritation. Avoid contact with eyes. Wash thoroughly with soap and water after handling. Wear rubber gloves when handling.

#### **FIRST AID:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or the product name and pest control product registration number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** This product contains petroleum distillates. Vomiting may cause aspiration pneumonia.

**STORAGE:** Store in original container in a cool dry well ventilated area; keep away from heat source.

**DISPOSAL:** When container is empty, press valve to release all remaining pressure. Wrap and discard empty container in household garbage.
