#### DO NOT USE ON CATS

Toxic to cats. Cats that actively groom or engage in close physical contact with treated dogs may be at risk of serious harm, including death.

Sentry Squeez-On Flea, Tick & Mosquito Control for Dogs (over 30 kg) is an effective and easy to use product. It inhibits flea eggs laid on treated dogs from developing into biting adults for 2 months and controls fleas, mosquitoes, brown dog ticks, blacklegged (deer) ticks and American dog ticks for up to 3 weeks. Ticks present on the animal at the time of treatment may take several days to die. For effective flea and tick control, treatment of the pet should be combined with sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

**DIRECTIONS FOR USE**: This product contains permethrin and Nylar® pyriproxyfen. Do not apply another pest control product such as a shampoo, collar, or powder that contains permethrin or Nylar® pyriproxyfen to the treated animal after applying Sentry Squeez-On Flea, Tick & Mosquito Control for Dogs (over 30 kg).

Use ONLY on dogs over 3 months of age and weighing over 30 kg. DO

NOT USE ON CATS OR OTHER ANIMALS. Do not get this product in dog's eyes. DO NOT administer by mouth. Do not apply more often than once every 3-4 weeks. Reapply every month for continual pest control where there is an ongoing risk of infestation. Efficacy of the product may be affected by washing the pet. IF ONLY TICKS OR MOSQUITOES ARE A PROBLEM, IT IS NOT NECESSARY TO USE A PRODUCT WHICH CONTAINS PYRIPROXYFEN.

**HOW TO APPLY**: Apply the entire content of one tube (4.5 mL) of Sentry Squeez-On Flea, Tick & Mosquito Control for Dogs (over 30 kg) solution on one dog. Remove product tube from packaging by tearing along perforation. Hold the tube with notched end pointed up and away from face and body, cut off notched end of tube. Use narrow end of tube to part dog's hair and invert tube over the dog. Squeeze tube firmly to apply all the solution to the dog's back at skin level between the shoulder blades. Wrap the emptied tube and put in garbage.

A veterinarian should be consulted when pest infestation continues to be a problem on the pet.

Consult a veterinarian before using on sick, aged, pregnant or nursing animals receiving drug or other pesticide treatments.

**Side Effects:** Monitor your dog after application. Side effects may include: skin irritation such as redness or scratching, changes in behaviour such as agitation or lethargy; or gastrointestinal effects such as vomiting or loss of appetite.
