PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Causes eye irritation. DO NOT get in eyes. When mixing/loading the concentrate, wear chemical resistant gloves and goggles. Wash thoroughly after handling the product and before eating, drinking or smoking. Remove and wash contaminated clothes before re-use.

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

DIRECTIONS FOR USE

ACTIVATE PLUS ULTRA is a non-ionic, low-foam surfactant. It acts as a spreader and an activator when used with selected herbicides.

NOTE: Carefully read and follow the directions contained on the label of the herbicide with which ACTIVATE PLUS ULTRA is to be used.

USE RATES:

Use ACTIVATE PLUS ULTRA in conjunction with the post emergence use of the herbicides listed below at the recommended rates for optimum performance from the herbicide.

HERBICIDE	CROP	RATE OF ACTIVATE PLUS EXTRA
ASSURE®	Soybeans	2.5 L per 1000 L of spray mixture
ALLY®	Spring Wheat	2.0 L per 1000 L of spray mixture
PURSUIT®	Soybeans	2.5 L per 1000 L of spray mixture
ULTIM®	Field Corn	2.5 L per 1000 L of spray mixture
ACCENT®	Field Corn	2.0 L per 1000 L of spray mixture

MIXING INSTRUCTIONS:

Make sure the spray tank is thoroughly cleaned before mixing. Fill the spray tank half full with water. Add the required amount of herbicide as directed by its label with the agitator running. Ensure that the herbicide is completely mixed before proceeding to the next step. SLOWLY add the ACTIVATE PLUS ULTRA, agitating during the entire process. Continue to agitate while filling the tank with water and agitate before and during each application to insure a uniform spray.
