#### **DIRECTIONS FOR USE:**

SHAKE CAN WELL BEFORE USING. Test a small inconspicuous area for color fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and lightly spray. Cover fishbowls when spraying. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation.

## FOR INDOOR USE IN BUILDINGS HOW TO APPLY

DO NOT APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT. Apply as An indoor crack and crevice or spot treatment only. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. Spot treatment is localized to surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room.

### **INDOOR USE**

TO KILL ANTS: Thoroughly treat indoor building surfaces in hard to reach areas including, cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; garbage cans; localized areas of floors and floor coverings; and points of entry (e.g., around windows and doors). DO NOT exceed 18 g per m² (5 seconds per m²). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

### **OUTDOOR USE**

### FOR OUTDOOR USE ON ANT HILLS:

TO KILL ANTS: Directly spray ant hills and trails. DO NOT exceed 18 g per m<sup>2</sup> (5 seconds per m<sup>2</sup>). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

### **USE LIMITATIONS**

DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Any food/feed accidentally contaminated with spray solution must be discarded. DO NOT apply when people, pets or livestock are present. DO NOT allow people, pets or livestock to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, livestock or sources of electricity. DO NOT apply to furniture, mattresses, linens, toys, or clothing. DO NOT apply to overhead areas or in confined spaces (for example, indoors in attics, crawlspaces, small storage rooms, closets and outdoors to eaves, soffits). When applied indoors, ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through skin. Provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. Avoid breathing spray mist. Wash thoroughly with soap and warm water after using. DO NOT CONTAMINATE ANIMAL FEEDING AREAS. Contents under pressure. DO NOT place in hot water or near radiators, stoves or other sources of heat, or store at temperatures

over 50°C as container may burst. DO NOT puncture or incinerate container or spray near open flame or spark, or while smoking. DO NOT spray asphalt shingles, as this product may stain them. DO NOT apply this product around equipment due to possibility of shock hazard.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms, birds and wildlife. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to evening when most bees are not foraging. Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness. Contains petroleum distillate. DISPOSAL: DO NOT reuse empty container. When the container is empty, press valve to release all remaining pressure. Wrap container in several layers of newspaper and discard in household garbage. STORAGE: Store in a cool dry area away from heat. Store this product away from food or feed.
