Avoid breathing vapor or mist. Use with adequate ventilation. Wear goggles or a face shield, chemical-resistant gloves, long pants, a long-sleeved shirt, and shoes plus socks during mixing/loading, clean up and repair. POTENTIAL SKIN SENSITIZER..
