FIRST AID:

If swallowed

If in eyes

Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

THIS PRODUCT CONTAINS PETROLEUM DISTILLATES. Vomiting may cause aspiration pneumonia. Treat symptomatically.

STORAGE:

Store in a cool, dry and well-ventilated place. Store product in original container only, away from other

pesticides, fertilizer, food, seed or feed. Do not contaminate water, food or feed by storage. Keep container closed to prevent spills, evaporation and contamination.

STORE ABOVE 0⁰C TO KEEP FROM FREEZING.

Freezing will result in crystals which settle to the bottom of the can. If allowed to freeze, place in a warm room (22⁰C) and roll and shake the can frequently for several days to redissolve.
