## **PRECAUTIONS**

## **FIRST AID**

## **STORAGE AND DISPOSAL**

**STORAGE:** Store in cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, or feed. Store in original container and out of reach of children, preferably in a locked storage area. FLUOXASTROBIN Technical Fungicide is not affected by freezing.

**DISPOSAL:** Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills, contact the manufacturer or the provincial regulatory agency.
