DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. For exterior use only. Not for use in dwellings. For above ground use only.

Apply by brush only and not by spraying or dipping. Do not use this product, or treated wood where wood preservative may contaminate food, feed, or drinking water.
