Earwigs, Spiders, Sowbugs, Silverfish and House Flies; **TO CONTROL:** Dog & Cat Fleas, Brown Dog Ticks, Carpet Beetles, Crickets, Firebrats, Red Flower Beetles and Rice Weevils.

GENERAL DIRECTIONS: SHAKE CONTAINER WELL. [Gently insert [or use] the (wand or applicator wand or extension tube or applicator hose or jet tube) into the spray nozzle before using.] This product is designed for applying into cracks, crevices or voids that are difficult to reach and where the insecticide won't be mopped away. The foaming action of this formula completely fills tight crevices leaving an insecticidal active residue. [Test a small inconspicuous area of the surface to be treated for color fastness & staining before full application. Do not apply to draperies, wallpaper or similar materials that may be stained

DO NOT apply as a space spray or broadcast application. Apply ONLY as a spot, crack and crevice or void treatment. Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. Void application applies to inaccessible, enclosed empty spaces of a structure.

Restrictions:

DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.

Unless otherwise stated on this label, DO NOT apply to furniture (excluding bed frames, bookcases and storage furniture), mattresses, linens, toys or clothing.

When applied indoors, DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets).

ANTS, COCKROACHES, EARWIGS, SPIDERS, SOWBUGS, SILVERFISH, DOG & CAT FLEAS, BROWN DOG TICKS, CARPET BEETLES, CRICKETS, FIREBRATS, RED FLOWER BEETLES, RICE WEEVILS: Thoroughly treat inside building surfaces including cracks, crevices in walls, floors and ceilings, beneath furniture (e.g. shelves and drawers). For ants, cockroaches, silverfish, sowbugs and spiders, also spray along door sills, baseboards and openings around sinks, drains and pipes, behind stoves and refrigerators, around window frames, in localized areas of attics and basements and around interior foundations. silverfish, also spray cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. For ants, also spray trails, nest and points of entry. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. FLEAS (ADULT AND LARVAE) AND BROWN DOG TICKS (ADULT AND NYMPHS): DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, moldings, window and door frames. Pet bedding may be entirely treated with this product and replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area. HOUSE FLIES: Spot treatment only. Spray inside building surfaces around points of entry (e.g. screen frames, windows and doors). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

Bed Bugs: FOR HARD TO REACH AREAS! [USE IN COMBINATION WITH A REGULAR (NON-FOAM) SPRAY BED BUG AEROSOL SPRAY] Apply spray foam directly to inside building surfaces including, cracks and crevices in the walls, floors and ceilings; along and behind baseboards and moldings and localized areas of walls behind and floors beneath furniture (e.g. bed and nightstand). Take beds apart, spray bed frame and springs including all joints. DO NOT apply to the mattress, headboard, footboard or furniture. Always test an area before spraying. FOR OUTDOOR USES:

ANTS, CRICKETS, FLEAS, SPIDERS, SOWBUGS AND BROWN DOG TICKS:

For use outdoors on the exterior surfaces of buildings and on patios, porches and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. For ants, spray onto ant trails, into ant nests and points of entry. Treatment must only be repeated after 14 days if pest problem persists or reoccurs. [Application to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Pre-test siding. Evaluate 30 minutes after test application for potential staining. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day. Do not apply to tapestries, wall paper or similar materials that may stain.]

FOR THE CONTROL OF ANTS OUTDOORS. Gently insert the (wand or applicator wand or extension tube or applicator hose or jet tube) as far as possible into hills, mounds, cracks, crevices, gaps, voids and trails in driveways, patios, sidewalks, or interlocking brick where ants hide. (Pull or Push or Depress) (trigger or nozzle) and allow foam to fill the area. Stop spraying when the foam comes back out the crack or crevice. For best results, treat all cracks and crevices in the area where ants are found. Spray trails, nests and points of entry. Treatment must only be repeated after 7 days if pest problem persists or reoccurs

HOUSE FLIES: Apply as a spot treatment only. Spray spots on outside surfaces of foundations, under eaves troughs, around light fixtures, and places where house flies enter (e.g., screens, doors, window frames). Houseflies will be killed when they land and crawl on the treated surfaces. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Cover fish bowls when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. After use, wash all surfaces that may contact food. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor.
