**DIRECTIONS FOR USE:**

This product contains (S)-methoprene. Do not apply another pest control product such as a shampoo, collar, or powder that contains (S)-methoprene to the treated animal after applying Hartz® InControl OneSpot® Drops for Cats and Kittens.

1. Remove one applicator tube from package and hold in an upright position.
2. Pull cap off. Turn the cap around and place on top of tube.
3. Press cap down to break the seal of tube.
4. Remove cap carefully. Position the tip of the tube on the cats back between the shoulder blades and squeeze out the entire contents of the tube.
5. Repeat every month.

Do not use this product more often than once every 4 weeks. Reapply every month for continual pest control in situations where there is an ongoing risk of pest infestation. Do not use on cats or kittens under 12 weeks of age. Do NOT administer by mouth. Consult a veterinarian before using on sick, aged, pregnant or nursing animals or animals receiving drug or other pesticide treatment. **RETAIN PACKAGING INFORMATION FOR FUTURE REFERENCE.**

**PRECAUTIONS:**

**HUMANS:** KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. May cause eye irritation. Avoid contact with mouth, eyes and clothing. Use rubber gloves when applying product. Avoid contact with pet until dry. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water.

**PETS:** Harmful if swallowed. Avoid contact with the cat's mouth, face, eyes and genitals. Care should be taken to prevent exposure of other pets that may be in close physical contact with the treated animal. Smaller animals are more likely to experience an adverse reaction. Observe carefully.

**Side Effects:** Monitor your cat after application. Side effects may include: skin irritation such as scratching or hair loss at the application site, or changes in behaviour such as agitation or lethargy. Gastrointestinal effects such as drooling, vomiting, or loss of appetite may also occur. If these or other side effects occur, consult your veterinarian or Hartz Canada, Inc. at 1-800-275-1414.

**FIRST AID****HUMANS:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove

contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**PETS:** Sensitivities may occur after using ANY pesticide for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Take container, label, or product name and Pest Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**STORAGE AND DISPOSAL:** Store in a cool, dry place away from food and out of the reach of children. Do not reuse empty container. Wrap and dispose of empty container with household garbage.
