**PRECAUTIONS DANGER - CORROSIVE TO EYES HARMFUL IF  
ABSORBED THROUGH SKIN OR INHALED PREVENT ACCESS BY

DO NOT get in eyes, on skin or clothing. Wear goggles or face shield and rubber gloves when handling. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

**FIRST AID Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention. Call a poison control centre or doctor for further treatment advice. **If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

No specific antidote. Supportive care. Treatment based on the judgment of the physician in response to reactions of the patient.
