DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. May irritate eyes. Avoid direct inhalation or contact with eyes, skin or clothing. Wear waterproof gloves, long-sleeved shirt, long pants, socks with shoes and use a NIOSH-approved dust/mist filtering respirator or NIOSH-approved dust/mist filtering mask when handling the product. Wash thoroughly with soap and water after handling this product. Remove contaminated clothing and follow manufacturer's directions for cleaning/maintaining personal protective equipment (PPE) before reuse.

FIRST AID:

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or a doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth, if possible. Call a poison control center or a doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or a doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:

Store product in original container at 5°C or less. The product should be used within 24 months from the date of manufacture.

DISPOSAL:

Manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal, provincial or national regulations. For additional details and cleanup of spills, contact the manufacturer or the provincial regulatory agency.
