#### **DIRECTIONS FOR USE:**

Alleviates the annoyance from mosquitoes by repelling and killing mosquitoes and reducing the number of bites in an area up to 4.5 metres from the product (as large as an average-size deck or patio) for up to four hours. Effect is **not** immediate. For best results, allow 30 minutes for product to take effect. This product works well in outdoor areas where there is minimal air movement, such as decks, porches, patios, yards and campsites. Use one lantern per each 21.0 square metres (an area 4.5 x 4.5 metres or 15' x 15'). Use more lanterns in larger areas, spacing them to ensure adequate coverage.
