DIRECTIONS FOR USE

To be used only in the manufacture of insecticides which are registered under the *Pest Control Products Act*. This product is to be used with appropriate solvents and or carriers, and in the case of pressurized products, propellents, to produce an insecticide product.

Mix well in drum before sampling and each use.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

FIRST AID:

Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
