DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Fatal or poisonous if swallowed. May be fatal if inhaled. DO NOT inhale dusts or vapors. Corrosive to the eyes and skin. Potential skin sensitizer. DO NOT get in eyes, or on skin or clothing. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

STORAGE:

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.

DISPOSAL:

Canadian manufacturers using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills, contact the manufacturer or provincial regulatory agency.

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the PEST CONTROL PRODUCTS ACT to use this product in a way that is inconsistent with the directions on the label. The user assumes the risk to persons or property that arises from any such use of this product.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
