DIRECTIONS FOR USE: SHAKE WELL BEFORE USING. A product for use outdoors.

Kills flies, mosquitoes, black flies, gnats, moths, hornets, wasps. Spray only when air is still and temperature is under 32⁰C. Point special fogging nozzle away from you in a slightly downward direction. Fog area where insects are a nuisance and the surrounding bushes or grass. Fog will extend up to six metres from nozzle. Stand at least 2 metres from target. Spray beyond the immediate area where control is desired to achieve longer control. Repeat as necessary. This product only kills insects contacted by fog.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Do not puncture or incinerate. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50° C. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray. Wash hands after using. Keep from freezing. Avoid contact with maidenhair ferns. Do not contaminate any body of water.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure, then dispose in household garbage. Do not puncture or incinerate.
