PRECAUTIONS

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL

Causes eye irritation. DO NOT get in eyes. May irritate the skin. Avoid contact with skin. Potential skin sensitizer. Avoid inhaling/breathing vapours. Workers should wash hands before eating, drinking, chewing gum, using tobacco or the toilet. Remove personal protective equipment immediately after handling. As soon as possible, wash thoroughly and change into clean clothing.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

THIS PRODUCT CONTAINS A PETROLEUM DISTILLATE. Vomiting may cause aspiration pneumonia. The decision of whether to induce vomiting or not should be made by the attending physician. If lavage is performed, suggest endotracheal and/or oesophageal control. Danger from lung aspiration of petroleum based solvents must be weighed against toxicity when considering emptying the stomach. No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.
