DIRECTIONS FOR USE: To be used in the manufacture of products registered under the **PEST CONTROL PRODUCTS ACT**.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful or fatal if swallowed. Causes eye irritation. Corrosive to eyes. DO NOT get in eyes. Potential skin sensitizer. May irritate the skin. DO NOT get on skin. Wash thoroughly with soap and water after handling and before eating, drinking or smoking. Remove and wash contaminated clothing before reuse.

Formulators and other handlers must wear chemical-resistant gloves, goggles or face shield, coveralls over a long-sleeved shirt and long pants, shoes plus socks. DO NOT USE LEATHER OR CLOTH GLOVES.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
