PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wear protective gloves and face shield when handling. Remove any contaminated clothing immediately. Wash hands and exposed skin thoroughly after handling.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Calla poison control centre or doctor for treatment advice.
