DIRECTIONS:

General Information: Permethrin is a synthetic version of pyrethrins. Pyrethrins have long been known for rapid knockdown of insects. Although permethrin is more stable than pyrethrins, it is still degraded by the ultraviolet rays of the sun. This results in a relatively short residual life in the presence of sunlight. When protected from the sun, permethrin will provide residual/long lasting activity.

POULIN'S SUPER STRENGTH II is ready to use. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible.

Restrictions: DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people or pets are present. DO NOT allow people or pets to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, or sources of electricity. Unless otherwise stated on this label, DO NOT apply to furniture, mattresses, linens, toys or clothing. DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets). Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs). When applied outdoors on the exterior surfaces of buildings, DO NOT treat soil, turf or other plants adjacent to the building. DO NOT apply as a space spray or broadcast application.

The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying, treat a small area of the siding and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day. Do not apply to tapestries, wall paper or similar materials that may be stained. For all other surfaces, test a small inconspicuous area of the surface to be treated for color fastness & staining before full application.

How to Apply: DO NOT apply as a space spray or broadcast application. Apply as a crack and crevice or spot treatment only. Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

INSTRUCTIONS FOR INSIDE BUILDINGS:

TO KILL EARWIGS, AND TO CONTROL ANTS, COCKROACHES, CRICKETS, FIREBRATS, SILVERFISH, SOWBUGS, SPIDERS, RED FLOUR BEETLES, AND RICE WEEVILS: Direct the spray into cracks, crevices, behind shelves and drawers. For ants, cockroaches, silverfish, sowbugs and spiders, also spray along door sills, baseboards and openings around sinks, drains and pipes, behind stoves and refrigerators, around window frames, in localized areas of attics and basements and around interior foundations. For silverfish, also spray the cracks and crevices in bookcases. For ants, also spray trails, nest and points of entry. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL/KILL CLOTHES MOTHS: Remove all objects before treatment of bookcases, closets or other types of storage furniture where clothing, toys, towels and other items are stored. Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray to empty chests, closets, bureaus and other storages, directing the spray into cracks, joints and crevices. Treated furniture must be dry before replacing stored items. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL HOUSE FLIES: Spot treatment only. Spray inside around windows and doors where insects enter or rest. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL FLEAS (ADULT AND LARVAE) AND BROWN DOG TICKS (ADULT AND NYMPHS): Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and doorframes. Fresh bedding should be placed in animal quarters following treatment. Allow to dry thoroughly before allowing pets to contact treatment areas. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT spray pets with this product. Only treat pets with product specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. and washing the pet's bedding, living quarters, and surrounding area.

TO KILL BED BUGS: Apply spray directly into cracks and crevices where these pests are found or may hide along and behind baseboards, moldings and floors underneath objects such as the bed and nightstand. Apply directly to insect if possible. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

FOR USE ON INDOOR ORNAMENTAL PLANTS:

TO CONTROL APHIDS AND WHITEFLIES: Spray surfaces of upper and lower leaves of plants until damp, but not to the point of running off. Safe for use on most plants. Before treating delicate plants, spray only 1-2 leaves and wait 2 days to be sure the plant leaves are not damaged. Treatment must only be repeated if pest problem persists or reoccurs.

OUTDOORS ON THE EXTERIOR SURFACES OF BUILDINGS AND PATIOS:

TO CONTROL ANTS, CRICKETS, FLEAS, HOUSE FLIES, SPIDERS, SOWBUGS AND BROWN DOG TICKS: For use outdoors on the exterior surfaces of buildings and on patios, porches and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. For house flies, apply as a spot treatment only. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not use in areas where food is handled, prepared or stored. Wash thoroughly after handling and before smoking or eating. Cover fish aquariums before surface applications. After use and at least one (1) hour drying time, wash all surfaces that may contact food.

ENVIRONMENTAL PRECAUTIONS: Do not apply directly to lakes, rivers, streams, ponds, tidal marshes and estuaries. Toxic to aquatic organisms. Toxic to birds. Toxic to bees. Toxic to beneficial insects.

FIRST AID: If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DISPOSAL: Do not reuse empty container. Wrap empty container and discard in household garbage.
