# **DIRECTIONS FOR USE**

Weight per Tablet: 20 g

#### WARNING

Direct tablet contact may cause bleaching of spa surfaces. Automatic feeding devices employing these tablets must be totally free from traces of other spa sanitizers to avoid the probability of an explosion.

1. Maintain recommended daily levels as determined by testing kit.

Free available chlorine: 3.0–5.0 ppm

pH: 7.2-7.8

Total alkalinity: 125–150 ppm Calcium hardness: 150–200 ppm

If using an automatic chlorinator, fill the chamber(s) with JACUZZI SPA ACTION tablets and adjust flow rate, according to manufacturer's recommendations, to maintain proper chlorine residual. Adding JACUZZI SPA ACTION tablets to the pool's skimmer basket is an alternative chlorine feed method.

- Superchlorinate a freshly filled spa by adding 20 g of JACUZZI SPA ACTION per 1000 L of spa water. Maintain water circulation at least 1 hour before using (always measure your free available chlorine level before using the spa to make sure it falls within the recommended levels). Repeat superchlorination procedure after each use period.
- Maintain proper chlorine residual by adding 10 g of JACUZZI SPA ACTION per 1000 L of spa water, daily or as needed.

Persistent foam formation, turbid, or malodorous water are indicators of inadequate sanitizer levels. To correct such conditions, superchlorinate spa water by adding 30 g of **JACUZZI SPA ACTION** per 1000 L of spa water. Maintain circulation at least 1 hour and wait 4 hours before using the spa (always measure your free available chlorine level before using the spa to make sure it falls within the recommended levels). Superchlorination with **JACUZZI SPA ACTION** will reduce total alkalinity. Make sure total alkalinity remains within the recommended levels.

- 4. JACUZZI SPA ACTION contains stabilizer (cyanuric acid) which will accumulate in spa water. The use of JACUZZI SPA ACTION to superchlorinate spa water will rapidly increase the stabilizer level. Keep stabilizer within 30–100 ppm range by dilution with fresh water.
- 5. For proper sanitation, spa must be completely drained periodically. The number of days between COMPLETE SPA DRAINAGE is equal to the volume of spa water in litres, divided by 10 times the maximum number of daily spa users. Refill spa with

water and repeat directions for use.

6. Maximum spa water usage temperature is 40°C. Duration in spa water at 40°C should not exceed 15 minutes.

#### **PRECAUTIONS**
