Read entire label carefully and use only as directed.

Chlorothalonil 720F is formulated for use on golf course tees, greens and fairways, ornamental turfgrass and ornamental herbs, shrubs and trees. It is highly effective for the control of a broad spectrum of turf and ornamental plant diseases when it is used according to the directions on this product label. Thorough, uniform coverage of plant surfaces is essential for good disease control.

# Mixing Instructions Chlorothalonil 720F Only

Apply Chlorothalonil 720F as a spray, using sufficient water to obtain adequate coverage of plant surfaces. Volume of spray to be used may vary, depending on crop and plant growth, from 200 to 4,000 liters per hectare for dilute sprays, and 50 to 100 liters per hectare for concentrate sprays. Use the higher spray volumes when foliage is dense and coverage is more difficult.

**Note:** Before preparing the spray mix, slowly invert the Chlorothalonil 720F container several times to assure uniform mixture.

Add the required amount of Chlorothalonil 720F to the spray tank while filling with water. Keep agitator running when filling spray tank and during spray operations.

DO NOT combine Chlorothalonil 720F in the spray tank with pesticides, surfactants or fertilizers unless your prior use has shown the combination physically compatible, effective and non-injurious under your conditions of use.

DO NOT APPLY BY AIR

# **DIRECTIONS FOR USE**

As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT allow effluent or run-off from greenhouses and mushroom houses containing this product to enter lakes, streams, ponds or other waters.

Field sprayer application: DO NOT apply during periods of dead calm. Avoid application of this

product when winds are gusty. DO NOT apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE) medium classification. Boom height must be 60 cm or less above the crop or ground.

#### Groundboom

If handling more than [340 kg a.i.] in one day, mixers and loaders must use a closed system.

Airblast application: DO NOT apply during periods of dead calm. Avoid application of this product when winds are gusty. DO NOT direct spray above plants to be treated. Turn off outward pointing nozzles at row ends and outer rows. DO NOT apply when windspeed is greater than 16 km/h at the application site as measured outside of the treatment area on the upwind side.

Wear coveralls over a long-sleeved shirt and long pants, chemical resistant gloves, socks and shoes during mixing, loading, clean-up, and repair activities. Wear a long sleeved-shirt, long pants, chemical resistant gloves, socks and shoes during application. Gloves are not required during application within a closed cab. Wear chemical-resistant gloves when leaving the cab for clean-up and repair.

In addition, wear chemical-resistant headgear during open cab airblast application. Chemical resistant headgear includes Sou'Wester hat, chemical-resistant rain hat or large brimmed waterproof hat and hood with sufficient neck protection.

If handling more than [122 kg a.i./day], an applicator must wear a respirator with a NIOSH approved organic vapour-removing cartridge with a prefilter approved for pesticides OR a NIOSH-approved canister approved for pesticides or use airblast equipment with an enclosed cab.

# Vegetative Filter Strips

A Vegetative Filter Strip (VFS) of at least 10 metres wide must be constructed and maintained. The VFS is required between the field edge and adjacent, downhill aquatic habitats to reduce risk to aquatic organisms from run-off. Aquatic habitats include, but are not limited to, lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, and estuaries.

The VFS is to be composed of grasses and may also include shrubs, trees, or other vegetation. Additional guidance can be found on the PMRA Environmental Risk Mitigation webpages.

Both VFS and spray drift buffer zones must be observed.

## **Spray Drift Buffer Zones:**

Use of the following spray methods or equipment DO NOT require a buffer zone: hand- held or backpack sprayer and spot treatment.

The spray drift buffer zones specified in the table below are required between the point of direct application and the closest downwind edge of sensitive freshwater habitats (such as lakes, rivers,

sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands) and estuarine/marine habitats.

For tank mixes, consult the labels of the tank-mix partners and observe the largest (most restrictive) buffer zone of the products involved in the tank mixture and apply using the coarsest spray (ASAE) category indicated on the labels for those tank mix partners.

The buffer zones for this product can be modified based on weather conditions and spray equipment configuration by accessing the Buffer Zone Calculator on the Pesticides portion of the Canada.ca web site. This tool cannot be used to reduce the vegetative filter strips.

Sod farm turf treated with Chlorothalonil 720F prior to harvest must be mechanically cut, rolled and harvested.

This product is not to be used around homes or other residential areas such as parks, school grounds, and playing fields. It is not for use by homeowners or other uncertified users.

Do not apply this product in a way that will contact workers or other persons or pets either directly or indirectly thorough drift.

**Turf**: DO NOT mow or water after treatment until spray deposit on turfgrass is thoroughly dry; Chlorothalonil 720F should always be used in conjunction with good turf management practices.

# On Golf Course Tees, Greens, Fairways and Ornamental Turfgrass:

Apply Chlorothalonil 720F in an adequate amount of water to provide complete coverage. See table below for rates of product and application intervals. Apply Chlorothalonil 720F when conditions favor disease development and repeat applications as long as these conditions persist. Under severe disease conditions, use the curative rates.

#### **Tank Mixture:**

Chlorothalonil 720F can be tank mixed with QUALI-PRO® T-NEX 11.3 ME or Quali-Pro Iprodione 240 SE for control of Grey snow mould and Pink snow mould only.

Read the QUALI-PRO® T-NEX 11.3 ME, QUALI-PRO® PROPICONAZOLE 14.3 ME and Quali-Pro Iprodione 240 SE labels and follow the precautionary statements and directions for use. Follow the most restrictive instructions and the greatest interval of application on the labels of the products to be tank-mixed.

- 1. Always check the tank mix compatibility of QUALI-PRO® T-NEX 11.3 ME, QUALI-PRO® PROPICONAZOLE 14.3 ME or Quali-Pro Iprodione 240 SE using a jar test with proportionate amounts of Chlorothalonil 720F, and water, before mixing in the spray tank.
- 2. Provide sufficient jet or mechanical agitation during filling and application to keep the

- 3. Fill tank at least ½ full of clean water.
- 4. If using using Quali-Pro Iprodione 240 SE, QUALI-PRO® T-NEX 11.3 ME or QUALI-PRO® PROPICONAZOLE 14.3 ME as a tank mix partner add them first then add Chlorothalonil 720F next.
- 5. Do not leave tank mix combinations in the spray tank for prolonged periods without agitation. Mix and apply them at the same day.

## ORNAMENTALS AND CONIFERS

Apply Chlorothalonil 720F at rate of 1.7 liters per 1000 liters of water unless other directions are given in the tables below. For outdoor ornamentals, apply sufficient spray to obtain adequate coverage, but do not exceed 2000 liters of water per hectare. For uncut flowers, begin application as directed for each species and disease condition cited and repeat once after 7 days, for a maximum of 2 total applications a year. For cut flowers, apply once only. During periods when conditions favor severe disease incidence, generally cloudy or wet weather, use the higher rate specified and the shortest indicated interval between applications.

Chlorothalonil 720F may be used in a greenhouse, except on cut flowers. For greenhouse use, apply once at a rate of 1.7 liters per 1000 liters of water, with a maximum spray volume of 1000 L/ha, unless other directions are given in the tables below. Applicators and attending personnel should wear protective clothing including long sleeves, gloves, goggles or eye shield plus a face-fitting respirator specifically designed to remove organic pesticide vapors and particulates. DO NOT use mistblowers or high pressure spray equipment when making applications of Chlorothalonil 720F in greenhouses. Use of Chlorothalonil 720F is recommended for disease control on the ornamentals and conifers listed in the tables below. Use of Chlorothalonil 720F is not recommended for species that are not listed.

#### RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, Chlorothalonil 720F contains a Group M5 fungicide. Any fungal population may contain individuals naturally resistant to Chlorothalonil 720F and other Group M5 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance management strategies should be followed.

# To delay fungicide resistance:

- Where possible, rotate the use of Chlorothalonil 720F or other Group M5 fungicides with different groups that control the same pathogens.
- Avoid application of more than the maximum number listed in the label and consecutive sprays of Chlorothalonil 720F or other fungicides in the same group in a season.
- Use tank mixtures with fungicides from a different group that is effective on target pathogen when such use is permitted.
- Fungicide use should be based on an IPM program that includes scouting, historical information related to pesticide use and crop rotation and considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well cultural, biological and other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications.
- Monitor treated fungal populations for sign of resistance development. Notify Adama Agricultural Solutions Canada Ltd. if reduced sensitivity of the pathogen to Chlorothalonil 720F is suspected.
- If disease continues to progress after treatment with this product, do not increase the use rate. Discontinue use of this product, and switch to another fungicide with a different target site of action, if available.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance management and/or IPM recommendations for specific crops and disease problems in your area.
