DIRECTIONS FOR USE

FABRIC AND CARPET[†] ADVISORY STATEMENT: Before you clean, test a small, hidden area for colourfastness and examine when dry. If colour is affected, do not use. Before using this product on upholstery, look for manufacturers' cleanability code tag. Use on upholstery coded "WS" or "W". Do not use on upholstery coded "X" or "S". Do not use on velvet, silk, vinyl or leather upholstery. Do not use on wool carpet. Remove solid residue and blot excess liquid with a clean, colour-safe, absorbent cloth.

For use on carpet[†]:

To use as a pretreat & sanitizer: Turn nozzle to spray position and spray a light even coating over soiled area until wet. Allow to remain wet for 1 hour. Deep clean following your machine's guide.

For use on soft surfaces other than carpet[†]:

To spot clean & sanitize: Spray a light even coating on soiled area until damp. Allow area to remain damp for one minute. Gently blot with a clean, damp, colour-safe cloth. Repeat as needed. Let air dry.

To deodorize or freshen: Spray until slightly damp to eliminate odours. For difficult odours, repeat application. Let air dry.
