**DIRECTIONS FOR USE:**

**General Directions:** SHAKE CAN WELL BEFORE USING. Remove protective cap and insert the extension tube into the spray nozzle. This product is designed for applying into cracks, crevices, or tight areas that are difficult to reach. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Cover fish bowls and remove pets for one hour when spraying. Within the specified use location, to enhance effectiveness of this product, apply this product directly to ants where possible. Good sanitary practices should be maintained to prevent re-infestation.

**How to Apply:**

DO NOT apply as a space spray or broadcast application. Apply as a crack and crevice treatment only. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

**Indoors of Buildings:**

Thoroughly treat indoor building surfaces in hard to reach places including, cracks, crevices in walls, floors and ceilings; along and behind baseboards; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**Outdoors on Ant Hills:**

To kill ants outdoors, gently insert the extension tube as far as possible into cracks and crevices in driveways, patios, sidewalks, or interlocking brick where ants hide. Push nozzle and allow foam to fill the area. Stop spraying when the foam comes back out the crack or crevice. For best results, treat all cracks and crevices in the area where ants are found. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**Restrictions:** DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people, pets or livestock are present. DO NOT allow people, pets or livestock to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, livestock or sources of electricity. DO NOT apply to furniture, mattresses, linens, toys, or clothing. When applied indoors, DO NOT apply to overhead areas or in confined spaces (e.g. attics, crawlspaces, small storage rooms, closets, eaves, soffits). When applied indoors, ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. When applied outdoors, DO NOT apply in areas

where plants are grown for food or feed (e.g., vegetables, fruit, herbs).

**PRECAUTIONS:**
