#### **DIRECTIONS FOR USE:**

This product contains (S)-methoprene. Do not apply another pest control product such as a shampoo, collar, or powder that contains (S)-methoprene to the treated animal after applying Hartz® First Defense ® OneSpot® Treatment for Cats and Kittens.

- 1. Remove one applicator tube from package and hold in an upright position.
- 2. Pull cap off. Turn the cap around and place on top of tube.
- 3. Press cap down to break the seal of tube.
- 4. Remove cap carefully. Position the tip of the tube on the cats back between the shoulder blades and squeeze out the entire contents of the tube.
- 5. Repeat every month.
