PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed, inhaled or absorbed through the skin. Do not get in eyes, on skin or clothing. Wear goggles or face shield and rubber gloves when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention

If swallowed:

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 15 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

No specific antidote. Treat symptomatically. Treatment based on the judgment of the physician in response to reactions of the patient. For further information consult the Material Safety Data Sheet.

ENVIRONMENTAL HAZARDS

Do not allow this material or waste water or solvent which contains it to discharge into lakes, streams, ponds, public waters or sewers.

STORAGE

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat. Do not contaminate water, food, feed or fertilizer during storage.
