## **DIRECTIONS FOR USE**

To be used only in the manufacturing, formulating or repackaging of a pesticide which is registered under the **PEST CONTROL PRODUCTS ACT**.

## **PRECAUTIONS**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.** Dangerous gas formed when mixed with acid. Do not mix with any other chemical. Strong oxidizing agent. May cause fire or explosion if contaminated. **CORROSIVE** to the eyes and skin. **DO NOT** get in eyes or on skin. Harmful or fatal if swallowed. May be fatal if inhaled. Avoid inhaling dust. Keep container closed and store in a cool, dry location. Rinse thoroughly before discarding. Do not re-use.

## **FIRST AID**

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

## **TOXICOLOGICAL INFORMATION**

Treat symptomatically.
