EMZONE 2 HR INSECT REPELLENT GENTLE MIST SPRAY KIDS has a unique formula that is a clear, non greasy, non foamy & non chilling spray, packaged in an Eco-Can that allows you to hold the can and spray in any direction, even upside down.

DIRECTIONS: Shake well. Repels mosquitoes for 2 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks, and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 2 hours if necessary. Spray clothing and exposed skin except face. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50C. Do not spray near open flame or spark, or while smoking. Causes eye irritation. DO NOT get in eyes. Avoid contact with mouth. Avoid contact with plants, plastic and fabrics such as rayon, dynel, and acetate. May damage furniture finishes, plastics, and painted surfaces. Keep away from open flame or spark. Supervise applications on children. Do not use on infants under 6 months of age. In 6 month to 2 year olds, do not apply more than once a day. Avoid application to child's hands. Not for daily use. In 2-12 year olds, do not apply more than 3 times per day. Do not contaminate food, utensils or any body of water.

FIRST AID: If irritation or other adverse effects develop, wash affected area with soap and water immediately. Seek medical attention if symptoms persist. If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press valve to release pressure. Do not puncture or incinerate. Wrap empty container and discard in household garbage.
