**DIRECTIONS FOR USE:**

To be used only in the manufacture (formulating, repackaging, repouring) of a pest control product solely for export from Canada.

**PRECAUTIONS:**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL, May be harmful if swallowed, inhaled or absorbed through skin. Avoid breathing dust or vapours. Use with adequate ventilation. Causes eye irritation. May cause skin irritation. Do not get into eyes, skin or on clothing. Wear suitable chemical resistant gloves and goggles or face shield when handling. When using, do not eat, drink or smoke. Wash skin thoroughly with soap and water after handling. Remove contaminated clothing immediately after use. Store and wash separately from household laundry before reuse. Do not contaminate any body of water.

**FIRST AID:**

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**In case of skin or clothing contact**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Probable mucosal damage may contraindicate the use of gastric lavage. No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.
