IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

#### DIRECTIONS FOR USE:

1. Initial dosage for pool water having no visible algae is 70 mL of Blueprint Algae Break 60 per 10,000 L of pool water.
2. Weekly maintenance dosage is 25 mL of Blueprint Algae Break 60 per 10,000 L of pool water.
3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 100 mL of Blueprint Algae Break 60 per 10,000 L of pool water.
