DIRECTIONS FOR USE: This odourless and non-staining powder can be used without fear of damage to pets, fish, birds or wildlife. Remains effective in control as long as King Eco-Way Bug Killer Dust is present. Kills many crawling domestic household and garden pests such as Cockroaches, Earwigs, Ants, Fleas, Silverfish, Crickets, Millipedes, Centipedes, Colorado Potato Beetle, and Caterpillars. Apply directly from this container.

INDOOR USE: Lightly coat at the rate of 50 grams per 10 m² the areas where these pests are found or hide such as cracks and crevices, behind and beneath stoves, refrigerators, sinks, cabinets, baseboards, garbage cans, around pipes and drains, window frames and in attics and basements. Hit insects directly when possible. Repeat treatment as necessary.

OUTDOOR USE: Lightly coat the areas where these pests are found or may hide including patios, windows, door frames and sills, outside of entrance ways, around foundations, and along ant trails. Apply directly to the insect if possible or to the foliage where insects are present or may hide. Repeat treatment as necessary.

IN THE GARDEN: For use on fruits, vegetables and flowers. Apply directly to the insect if possible or apply a thin layer of powder on soil surface around the base of plants, vegetables and along flower beds. Can be applied up to the day of harvest. Repeat treatment as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Do not use as a general space spray. Avoid breathing dust. Avoid contact with eyes. Not for direct food contact.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. **If in eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for further treatment advice.
