## **DIRECTIONS FOR USE**

DENSIL C-98 is a broad spectrum microbicide for control of fungi. Its high degree of activity provides excellent performance characteristics for use as a mildewcide in latex exterior and interior emulsion paints and solvent-based paints. DENSIL C-98 has several desirable properties which are important in manufacturing fungus resistant paint.

These are:

extremely low water solubility

low vapour pressure

fine particle size

Latex Exterior and Interior Emulsion Paints - For exterior paints, use 0.5-0.85 kg per 100 litres. For interiors paints, use 0.25-0.5 kg per 100 litres.

Solvent-Based Paints - Use 0.5-0.85 kg per 100 litres.

RECOMMENDATIONS FOR USING DENSIL C-98

**Latex Emulsion Paints** 

DENSIL C-98, a micromilled powder, is best dispersed during the pigment grinding operation. Grinding equipment normally used in the paint industry is entirely satisfactory.

Generally, 0.5-0.85 kg of DENSIL C-98 per 100 litres of exterior paint are sufficient for effective mildew control in the paint film. In extreme mildew areas, such as the West Coast, levels of up to 0.85 kg are recommended. Levels of 0.25-0.5 kg have been found effective in interior latex paint. DENSIL C-98, at these recommended levels, may be used as a component of paints used in non-food contact surfaces in food plants.

DENSIL C-98 is compatible with zinc oxide in latex paints.

DENSIL C-98 can be used with either unmodified or alkyd modified acrylic, vinyl acrylic or polyvinyl acetate latexes.

If a can preservative is used in combination with DENSIL C-98, its compatibility with DENSIL C-98 should be examined first. Our studies indicate that certain can preservatives appear to react with DENSIL C-98 to produce a yellowing in the can.

**Solvent-Based Exterior Paints** 

DENSIL C-98 can be used to aid in protecting solvent-based exterior paint films from mold growth at treatment levels of 0.5-0.85 kg per 100 litres. Again, dispersion is readily accomplished during the pigment grinding operation. As in the case of latex paints, zinc oxide can be used with DENSIL C-98.

## **PRECAUTIONS**

### KEEP OUT OF REACH OF CHILDREN

DO NOT mix and load more than 4.6 kg per person per day when mixing and loading. This restriction is in place to minimize exposure to individual handlers. Mixing and loading may need to be performed over multiple days or using multiple handlers.

Do not get in eyes. DENSIL C-98 is capable of causing severe eye damage. Wear goggles or eye shield when handling this product. See First Aid Procedures.

Avoid contact with skin or clothing. See First Aid Procedures.

Do not take internally. Avoid breathing dust. May be fatal if inhaled.

Note: DENSIL C-98 may produce temporary allergic side effects characterized by redness of the eyes, mild bronchial irritation and redness or rash on exposed skin areas. Persons having an allergic reaction should contact a physician. See First Aid Procedures.

Wear goggles or eye shield to protect eyes when handling or using DENSIL C-98.

Wear chemical-resistant coveralls over a long-sleeved shirt, and long pants, chemical-resistant gloves, socks, chemical-resistant footwear and a respirator with a NIOSH-approved organic-vapour-removing cartridge with a prefilter approved for pesticides, or a NIOSH-approved canister approved for pesticides during mixing, loading, clean-up and repair.

## **DISPOSAL**

Rinse the emptied container thoroughly and add the rinsings to the treatment site.
