DIRECTIONS FOR USE:

Preservation uses: Slurries used in papermaking processes. DOSAGES OF PREVENTOL OF 45 BASED ON WEIGHT OF THE FORMULATED SLURRY:

Calcium carbonate slurry:	0.030.045% (1.5-2.25 kg of product per 5,000 kg of slurry)
Talcum slurry:	0.030.045% (1.5-2.25 kg of product per 5,000 kg of slurry)
Titanium oxide slurry:	0.030.045% (1.5-2.25 kg of product per 5,000 kg of slurry)

To preserve calcium carbonate, talcum and titanium oxide slurries. Applied as fillers in the wetend production of paper and paperboard including those that contact foods. Preventol OF 45 should be metered directly into the cooling step after the temperature falls below 50 degrees Celsius and homogenously distributed by stirring.
