DIRECTIONS FOR USE

To be used only in the manufacture of a growth control regulator registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed, CORROSIVE TO EYES, DO NOT get in eyes, may irritate skin, avoid contact with skin. Harmful if inhaled. Avoid inhaling/breathing vapour or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Wear a NIOSH-approved cartridge respirator, coveralls over a long-sleeved shirt and long pants, chemical resistant gloves and goggles or a face shield while handling the product (e.g., loading, application, and during clean-up and repair activities). Apply in a well-ventilated area.

ENVIRONMENTAL PRECAUTIONS

TOXIC to aquatic organisms. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

FIRST AID

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

Emergency medical treatment: Treat symptomatically. Acute oral overexposure to copper hydroxide, a major component of this product, may cause hypotension, haemolysis, and rarely, methemoglobinemia. Severe intoxication is associated with serum copper levels greater than 500 mcg/dl. Copper hydroxide is emetic, however, dilution with fluids, absorption with activated charcoal, or lavage may be indicated. Chelation therapy with BAL or D-penicillamine has proved useful in cases of acute exposure. Unless extensive vomiting has occurred, empty the stomach by gastric lavage with water,

milk, sodium bicarbonate solution or a 0.1% solution of potassium ferrocyanide (Gosselin, Clinical Toxicology of Commercial Product, 5th edition). Administration of gastric lavage should be performed by qualified medical personnel. Probable mucosal damage may contraindicate use of gastric lavage.

STORAGE

Store this product away from food or feed. Store in a cool, dry place. Store above 0°C and protect from freezing.

DISPOSAL

DO NOT reuse this container for any other purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:
