DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*. **DO NOT** discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

PRECAUTIONS:
