For horse application - Use the 'white actuator' – coarse spray

For outdoor and space application. Use the 'red actuator' – fine mist

**HORSES:** To control mosquitoes, biting midges, black flies, stable flies and horn flies, apply a light spray sufficient to wet the surface of the hair. To control stable flies, horse flies and face flies, apply at the rate of 60 g per adult horse, sufficient to wet the hair thoroughly. Repeat treatment as needed but not more than once a day. Not to be used on newborn or nursing foals. Do not soak skin. Do not apply to back of animal prior to saddling. Do not cover horses after treatment. Do not spray on face of animal; wipe on face avoiding eyes and mouth. To use as a wipe-on, moisten a soft cloth with this product and apply by rubbing against the natural lay of the hair. If irritation appears, discontinue use

**SPACE SPRAYING:** Adjust nozzle to deliver the mist spray pattern to control house flies, flying moths, gnats, hornets, mosquitoes, and wasps. Close doors and windows, adjusting nozzle to deliver a fine spray. Spray upwards in the air, directing spray into the corners of the room. Work backwards toward exit. Keep room closed for 15 minutes, then ventilate. Keep spray at least 1 m from interior walls, fabrics and furniture. Insects must be contacted to be killed.

**OUTDOOR USE:** Adjust nozzle to deliver the mist spray pattern to control of house flies, mosquitoes, hornets and wasps. Direct mist upwards in sweeping motions to all areas where insects are congregating such as porches, garages, storage areas, barns, under eaves, and around windows & doors, domestic kennels, domestic farms, and domestic stables. Insects must be contacted to be killed.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Harmful if swallowed, inhaled or absorbed through skin. Not for use on humans. Wash after use. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Cover or remove aquaria and remove pets for 1 hour. Vacate room after treatment and ventilate before reoccupying. Do not use on sick animals or animals under drug or pesticide treatment. Before use on pregnant animal, consult a veterinarian. Wash contaminated clothing before reuse. Do not contaminate feed, food, litter or food-handling equipment. Do not use in areas where beekeeping equipment or supplies are stored, or where milk is stored or processed. Keep from freezing. **CONTENTS UNDER PRESSURE.** Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate can or store at temperatures over 50°C.

**STORAGE:** Store away from feed and food.

**ENVIRONMENTAL HAZARDS:** Do not contaminate any body of water. Highly toxic to crabs, fish and shrimp. Harmful to wildlife if allowed to contaminate lakes and streams.

**FIRST AID:** If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
