**DIRECTIONS FOR USE:**

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

**FIRST AID:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and pest control product registration number with you when seeking medical attention. If patient is unconscious, give him air.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapours. Dangerous gas formed when mixed with acid. Do Not mix with any other chemical. Strong oxidizing agent. May cause fire or explosion if contaminated. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes. Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.
