# GATEWAY ADJUVANT FOR USE WITH RANGE AND PASTURE, AND NON-CROP INDUSTRIAL VEGETATION MANAGEMENT PRODUCTS

Gateway Adjuvant is a spray tank adjuvant for use with broadleaf, perennial, woody shrub, tree and bareground products that require use of a NIS, MSO, or an Oil/NIS blend adjuvants. Products include, but not limited to: Aspect<sup>™</sup>, Garlon<sup>™</sup> XRT, ClearView<sup>™</sup>, Reclaim<sup>™</sup> II Tank Mix, Sightline<sup>™</sup> A, and glyphosate formulations including potassium and isopropylamine salts.

## **Application Rates**

Gateway Adjuvant can be used with herbicides that require an adjuvant. Apply at a rate range of 0.25 to 1.0% V/V (2.5 L Gateway Adjuvant /1000 L spray mixture to 10 L Gateway Adjuvant /1000 L spray mixture). The higher rate is for use under adverse conditions, such as dense weed population, late weed growth stage, or poor environmental conditions, or with certain multiple product tank mixes.

### Tank Mixtures
