PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Strong oxidizing agent. Contamination with moisture, dirt, organic matter or other chemicals (including other pool chemicals) or other foreign matter may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible generation of fire and explosion. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
