DIRECTIONS FOR USE

To be used only in the manufacture of a fungicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

1. **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**
2. Fatal or poisonous if swallowed. May irritate the skin. Avoid contact with skin.
3. Avoid contact with eyes, skin and clothing.
4. Wear protective equipment and clothing, including chemical-resistant gloves, coveralls over long-sleeved shirt, long pants, and shoes plus socks during loading and clean-up activities.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
