DIRECTIONS FOR USE:

To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. MULTICIDE® Intermediate 2086 is designed for use at the rate of 2.25% (wt.) with appropriate carriers and propellents in the preparation of water-based insecticide sprays.

PRECAUTIONS:

PREVENT ACCES BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. Avoid inhalation of vapors or contact with eyes or skin. Avoid contamination of food and feedstuffs.

FIRST AID:

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled**, move person to fresh air. If person is not breathing, Call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms.

DISPOSAL & DECONTAMINATION:

Rinse empty container and add rinsings to formulation tank, if possible. Canadian formulators using this product should dispose of unwanted active and containers in accordance with municipal or provincial regulations. STORAGE:
